The data can be transferred to banks to effect payment of contracted services as well as third parties who may handle the management accounting, the tax and the compliance of obligations of a tax or social security nature. Except for the above and the cases in which there is a legal obligation, the data will not be passed on to third parties without prior consent and shall not be transferred to third countries.
